# Q5 Are you part of a social project (without a business model) or social business (you have a business model)? Or are you planning to start either the first or the latter?






# Q7 What is the legal form of your social project/ business?






### Q11 Have you ever applied for funding?







# Q14 Think about your most important funding up until now. How long did it take between applying and receiving the grant?








## Q18 What is your preferred method of application for funding?


## Q19 What is your preferred wrap-up/evaluation to a funding programme?


# Q20 On a scale of 1 to 10, how easy would you rate accessing funding to help you grow your social project/ business in Europe?


# Q21 On a scale of 1 to 10, how easy would you rate accessing relevant knowledge to help you grow your social project/ business in Europe?

# Q22 Which areas do you think receive too little funding? (Multiple answers possible)






# Q24 If no, would blocked days or weeks over a period of several months work for you and your team?





### Q26 If so, how much time would you need to prepare?




